## SECOND AMENDMENT TO THE DECLARATION

OF

### LaVISTA AT LIGHTHOUSE POINT CONDOMINIUMS

Pursuant to the provisions of Neb. Rev. Stat. §76-854 of the Nebraska Condominium Act and paragraph 37 in the Declaration of LaVista at Lighthouse Point Condominiums, which was recorded on July 29, 2004 as Inst. 2004-7164 and amended on October 15, 2004 as Inst. 2004-9824 (hereinafter collectively referred to as the "said Declaration"), the undersigned, being at least sixty-seven percent (67%) of the currently existing twenty-seven (27) Condominium Association Unit Members and the said Condominium being more particularly described as follows:

Units A-1, A-2, A-3, A-4, B-1, B-2, B-3, B-4, C-1, C-2, C-3, C-4, D-1, D-2, D-3, D-4, E-1, E-2, E-3, E-4, F-1, F-2, F-3, F-4, G-1, G-2, G-3, H-1, H-2, H-3, H-4, I-1, I-2, I-3, I-4, all in LaVista At Lighthouse Point Condominiums, as located on part of Lot 1, Block 7, Lighthouse Point, an addition to the City of Kearney, Buffalo County, Nebraska, according to a Declaration recorded on July 29, 2004 at Inst. 2004-7164, as amended at Inst. 2004-9824, together with the undivided interest in the common elements as described in said Declaration to be appurtenant to such unit;

do hereby make the following amendments to the said Declaration:

1. Inserting after the fifth subparagraph under paragraph 22, MAINTENANCE OF COMMON ELEMENTS, the following subparagraph:

"The Declarant/Developer may choose to voluntarily end said period of initial development control prior to thirty-two (32) of the thirty-five (35) condominium units being sold to third-party bona fide purchasers and to voluntarily surrender the right to appoint and remove officers and members of such Board of Directors/Executive Board and the right to approve specified actions of the association or the Board of Directors/Executive Board. The Declarant/Developer may do so by notifying the members of said intention at any regular or special meeting of members."

2. The last sentence of paragraph 30, COMMON EXPENSES AND LIEN, is removed in its entirety and insert in lieu thereof the following sentence:

"After thirty-two (32) of the thirty-five (35) units have been sold by the Declarant/Developer, or upon the Declarant/Developer's voluntary end of said period of initial development control, as set forth herein, whichever occurs first, the assessments shall be based upon a budget adopted at least annually by the association; prior to that time, the Declarant/Developer shall be responsible to calculate and compute the budget and the amount of the annual assessments, to be payable in monthly installments as provided herein."

3. The first sentence of paragraph 37, AMENDMENTS, is removed in its entirety and insert in lieu thereof the following sentence:

"The condominium established by this Declaration may be amended by the vote or agreement of at least 67% of the units owner members, subject to the provisions herein regarding the sale of thirty-two (32) of the thirty-five (35) units by
